**NO. ED/PLN/GT-SR.L/24/** : It is hereby notified for the information of all concerned that the Tentative Seniority List of Graduate Teachers 2025 has been published. A copy of the list is available on the Department's official website at <https://education.nagaland.gov.in>. Any claims and objections regarding the Tentative Seniority List shall be submitted within 30 days from the date of issuance of this notification.

The Tentative Seniority List of Graduate Teachers 2025 has been prepared based on the following criteria:

1. The Seniority List is drafted in accordance with the principles outlined in the judgment of the Hon'ble High Court in Writ Appeal No. 16(K) of 2017 and Writ Appeal No. 17(K) of 2017, dated 12/12/2019.
2. The cut-off date for the preparation of the seniority list is 31-03-2011.
3. Teachers regularized with effect from 01/04/2011 shall only be included in the Graduate Teachers' Seniority List after anomalies related to their PIMS are resolved. This step is necessary to expedite the publication of the Final Seniority List of Graduate Teachers as directed by the Hon'ble High Court in W.P (C) No.126 (K)2023.
4. Teachers listed in the Tentative Seniority List 2025 with incomplete documentation or incorrect data entries, such as Date of Appointment, Date of Birth, Date of Granting Graduate Scale, Date of Regularization are required to submit the necessary documents within the stipulated timeframe for rectification and consideration. Teachers who fail to provide the requisite documents within the given time will forfeit consideration for further promotions and may lose their seniority position.
5. Failure to submit Claims or Objections within the specified time will be deemed as validation of the existing entries. Claims or Objections submitted after the deadline will be considered invalid, and no further complaints will be entertained.
